

Care leavers

Information on how we can help 17 year olds who are currently in a social services care placement that is due to expire once they turn 18.

Applying to Barnet Homes for assistance

If you have been looked after by the local authority when you were between 16 and 17 years old, this placement will come to an end when you turn 18. A referral under Section 24 of the Housing Act 1996 will be made by social services to the Housing Options team.

You will be allocated a housing officer who will invite you to come for an assessment where they will look at your eligibility and housing need. It is important you bring all the documents they request to this appointment. These are:

- Your passport or birth certificate
- Details of your work or education so we know where suitable areas are
- Evidence of any medical conditions we should be aware of
- 6-month recent bank statement

Together you will put a Personalised Housing Plan in place. This will outline the steps you will both take to relieve your homelessness.

Your case worker will then process your case. 17- and 18-year olds leaving care will be generally placed into Band 2, our second highest priority band. Once you have been placed into this band, you will be nominated for suitable social tenancies.

If we are unable to place you into a property before your care placement expires, then you will be given emergency temporary accommodation until a suitable property is sourced. Every effort will be made to ensure that you are placed in an area that is suitable for you.

You do not have to be working or in education to qualify for assistance, but if you do not have an income, you will need to sign up for Housing Benefit to cover the rent once you have been placed into a suitable property. This is also the case if you need to access temporary accommodation.
