

# Debt advice & employment support

If you are having financial issues or trouble finding a job, find out about services that could provide practical advice and support.

#### Financial issues

Persons facing homelessness are frequently faced with rent or mortgage arrears, loss of income due to the benefit cap, and unemployment. You may need to seek advice around claiming benefits, money management, prioritising debts, or negotiating with creditors. You may also need support to start training, education, or seeking employment.

## **Get advice**

You should seek advice regarding your financial situation as soon as possible. You can get debt or money advice over the phone or online.

## **Applying to Barnet Homes for assistance**

You can approach our Housing Options service for assistance if you are homeless or at risk of homelessness. We will give you advice about finding somewhere to live and may make referrals to other organisations. We will open a homelessness application for you, and if you are eligible for assistance and are homeless or threatened with homelessness within 56 days you will be helped by one of your frontline teams. We may be able to prevent your homelessness if you are being evicted due to rent arrears or your property has become unaffordable. If you qualify for assistance with rehousing, we may provide emergency accommodation and we can help you move to a property in the private rented sector. Our Welfare Reform Task Force provides support and financial help with discretionary housing payment, council tax discretionary relief, crisis funds, free school meals, free childcare advice and free early education.
