Meet the contractors event

Following on from the notification in the January newsletter where we announced that Bouygues UK were appointed as the preferred contractor to carry out the construction works at the Fosters Estate; we would like to invite you to a "Virtual Meet the Contractor" event.

We would have liked to deliver the Meet the Contractor Event in person, however due to current government guidelines and social restrictions, we will be holding this event virtually, using Zoom.

The virtual session will take place between 17.30 and 18.45 on Thursday 18 March 2021.

You will also get the chance to view architect drawings and artists' impressions of the new buildings. We will conclude the event with an animation, showing a timeline of construction events from inception to handover.

During the session, the Bouygues Team (who will be carrying out the works) will provide key information on:

- an outline of what is happening and when
- method of construction and health and safety
- the locations of works, including site boundaries
- who to contact in the event of a query
- how the work will affect you or impact on you i.e. pedestrian access or planned road closures
- forthcoming training & employment opportunities
- information about a community app and how we will communicate with you
- out of hours contact details.

There will be a Q&A session for any questions you may have.
